### Investment Objective & Approach<sup>2</sup>

Grayscale Basic Attention Token Trust is one of the first securities solely and passively invested in the Basic Attention Token ("BAT") and enables investors to gain exposure to BAT in the form of a security while avoiding the challenges of buying, storing, and safekeeping BAT, directly. Shares (based on BAT per Share as indicated below) are designed to track the BAT market price, less fees and expenses. Basic Attention Token serves as the native digital currency for Brave, a blockchain-based digital advertising and services platform operating on the Ethereum Network. BAT is built on Ethereum in accordance with the ERC20 scripting standards and creation guidelines. Brave was founded in 2015 by Brendan Eich, the creator of the Javascript programming language and Mozilla Firefox. The purpose of BAT is to address privacy, fraud and opaqueness in web browsing and digital advertising, including cross-party data sharing and lost revenue to middlemen.

To date, the Product has not met its investment objective and the Shares of the Product quoted on OTC Markets Group has not reflected the value of digital assets held by the Product, less the Product's expenses and other liabilities, but instead have traded at both premiums and discounts to such value, with variations that have at times been substantial.

NAV is calculated using non-GAAP methodology. NAV per Share is calculated by dividing NAV by the number of shares currently outstanding.

5. The CoinDesk Basic Attention Token Price Index (GBAT) provides a USD-denominated reference rate for the spot price of Basic Attention Token(BAT). The index leverages real-time prices from multiple constituent exchanges to provide a representative spot price.

Therefore, the amount of digital assets represented by each share will gradually decline over time.
